# Our Mission & Vision

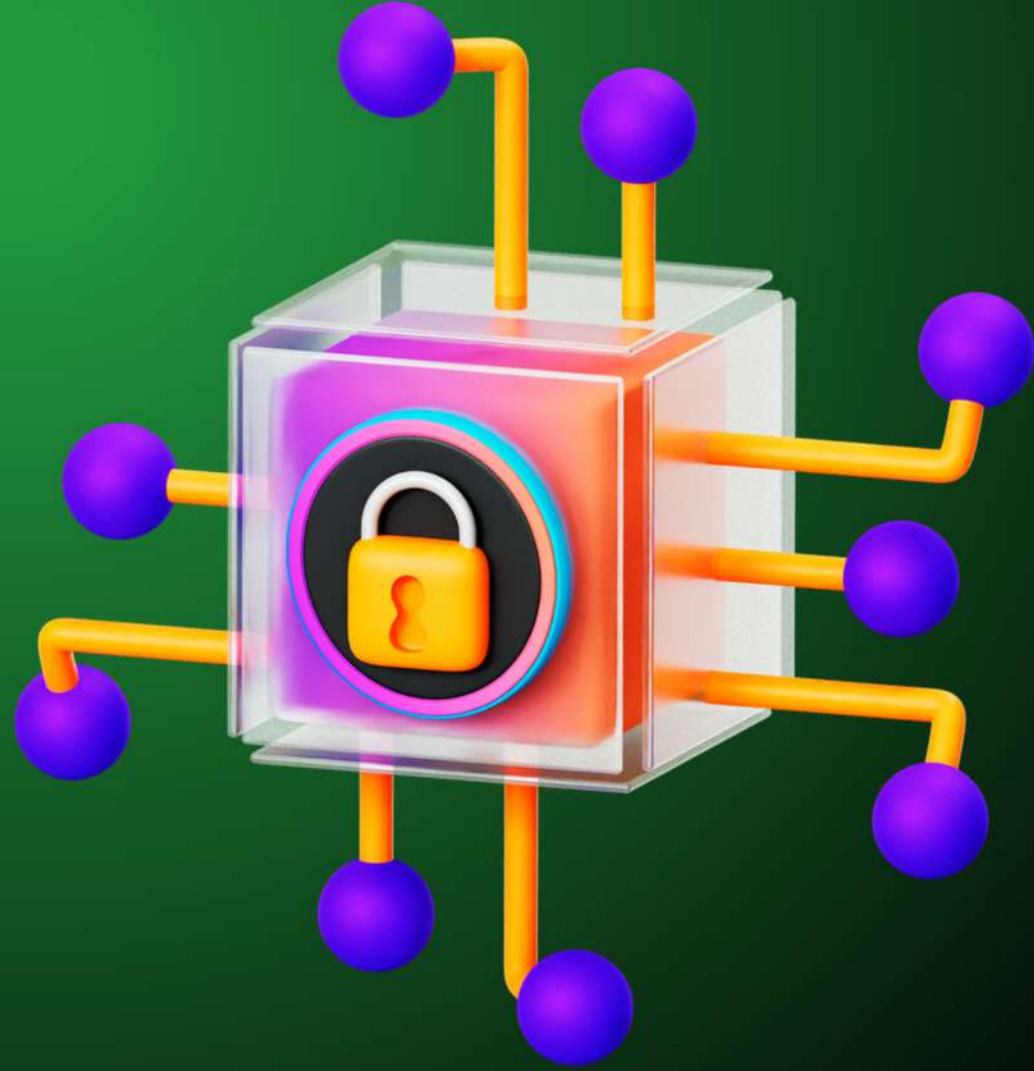
## **Mission:**

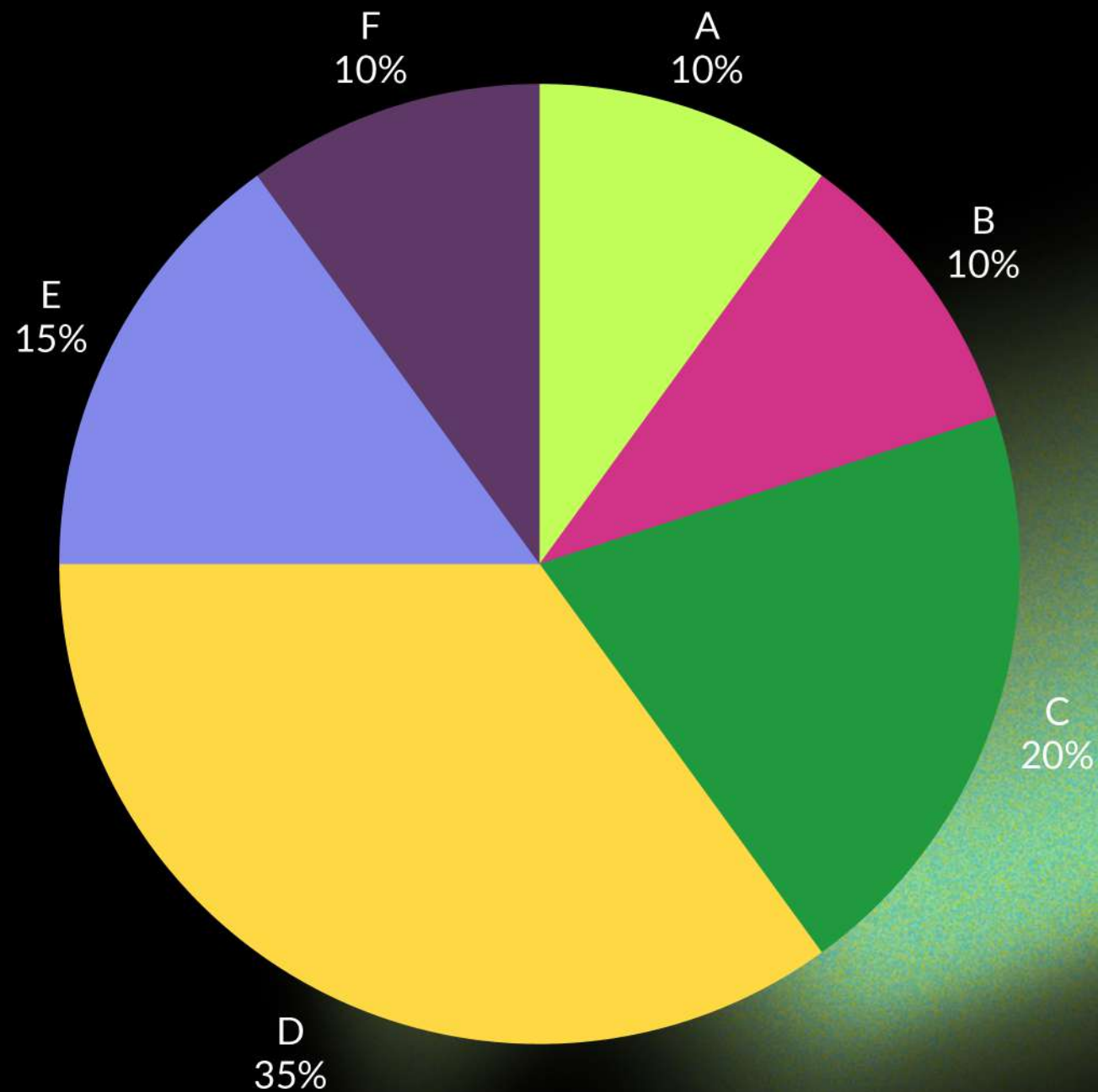

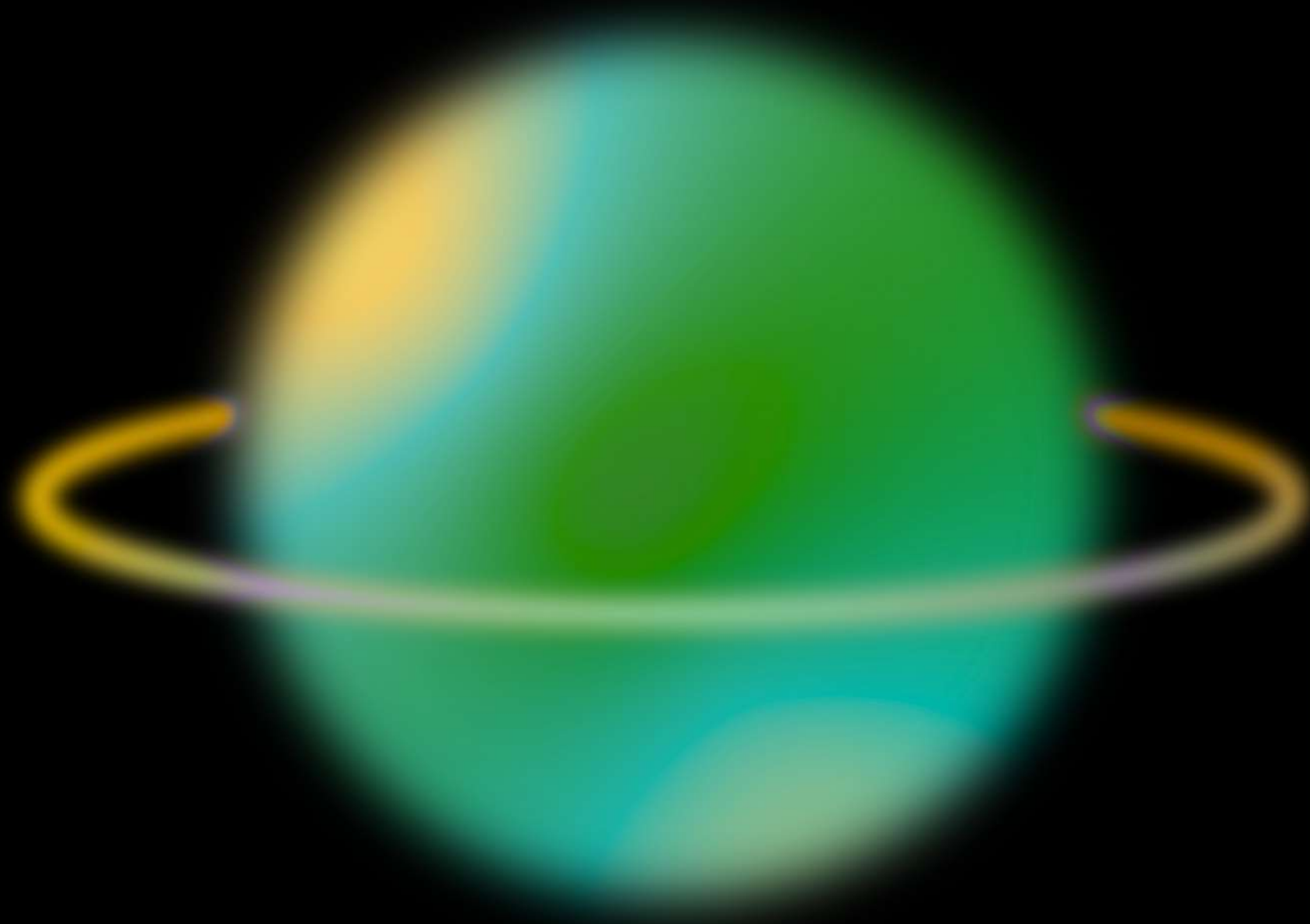

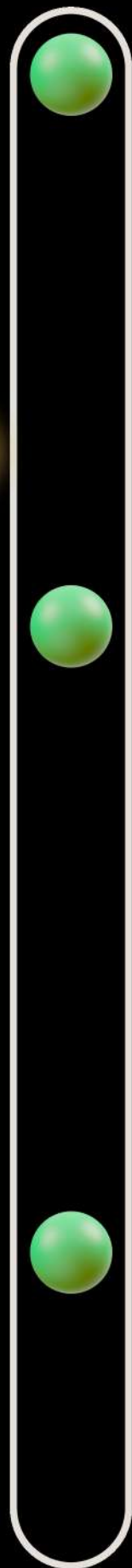
